Thank you for your interest in becoming an exhibiting artist member of Art on Main! We look forward to the opportunity to see your creative work and hope that it can find a place here with us. To help us make a decision that is most appropriate for the Gallery, and for you, please consider the following information and provide us with a selection of your very best!

If you work in more than one distinct medium and would like us to consider both categories of work, please submit separate application forms and samples for each. For example, jewelry and textiles or pottery and music.

Checklist – Please be sure that your completed application includes all of the following:

- Completed application sheet with all questions addressed **in full** – to help us understand your artistic work and process and your commitment to the demands of retail sales
- Artist statement and/or biography – to help us understand your artistic vision and journey
- Resume: galleries, exhibitions, art classes/workshops taken and taught – to help us understand your arts background and standing in the arts community
- Samples of your work – a selection of 5-10 pieces which will give us a cohesive representation of your work; our preference is for originals when possible*, and newer work rather than older especially if there have been changes in style or mastery. ***Please choose to send us your best.***
 - Please label and present items **as if for sale** – retail price should be clearly marked and hang tags attached if you use them
 - * If sending photos, be sure to label each with materials used, size, price

Timeline

Please RSVP ahead of the jury date, so that we can plan for our session. You are welcome to drop off or mail your application and work anytime in the 2 weeks leading up to a jury date; **no later than 10am** on the day of the jury. Regular Gallery hours are Monday through Saturday 10am-6pm all year; Sundays 11am-3pm May through December. You may also both drop off and pick up work on the day of the jury if you will be traveling from a distance (again, plan to arrive **no later than 10am**); in this instance, it is helpful if you send the paperwork ahead of time. Work is available to be picked up anytime after 2pm the day of the jury. If you have particular concerns about timing, please let us know.

You will receive a letter when a decision about welcoming your work to the Gallery has been made. We make every effort to send these within the week following the jury, but please do give us up to two weeks to fully craft our response.
